New Pension Scheme shall be applicable for fresh candidates as well as those who joined the Government service on or after 01-01-2004.

- Age : Below 30 years . (Relaxation as per Government of India Rules)
- Essential Qualification : i) Good MSc. Degree in Computer Science / Application/ IT
ii) Three (3) years experience in laboratory work (Computer Science/ Application/IT) in a recognized research institution / organization.
- Desirable Qualification : Experience in operation and maintenance of computational lab. Shell script programming skills, exposure to Unix environment including serving as super user , exposure in networking and distributed computing ,knowledge in computer security, basic skills in web server design and database management. Red Hat certified Engineer or equivalent ITIL/ITSM/CCMP/CCNP/PMP etc. from a reputed institution.

2. Sr. Laboratory Assistant : One(1) post (Unreserved)
- Pay Band + Grade Pay : PB-2, Rs. 9300-34800/- + GP Rs. 4600/-
- Age : Below 32 years . (Relaxation as per Government of India Rules)
- Essential Qualification : i) Science Graduate of a recognized University with combination of Physics/Chemistry and Life Sciences
ii) 7 years experience in laboratory work in areas as specified below :
- Spectrophotometry/Fluorimetry**
Protein separation/HPLC/FPLC
Gel Electrophoresis and related techniques.
- Desirable Qualification : Ability of recording scientific data and maintaining scientific instruments.

INSTRUCTION OF CANDIDATES:

1. Up-to-date curriculam vitae of the applicant should be submitted as an attachment (as pdf file only) with the online application form so as to reach by 14:00 hrs. IST on **02/01/2018**.
2. Only applications received online will be processed. Candidate should send the hard copy of the online application (with applicant's code which will be generated only after submitting the application) along with self attested copies of all certificates and testimonials to the Office of the Registrar, Bose Institute, P-1/12, CIT Scheme VII-M, Kolkata – 700 054, so as to reach **by 17/01/2018** till 15:00 hrs.(IST).
3. The System will not accept any application after 14:00 hrs. IST on **02/01/2018**.
4. Copies of Certificates/Testimonials need not be attached at this stage with the online application.
5. Eligibility criteria including the upper age limit will be reckoned on as on **09/12/2017**.
6. The Institute reserves the right to hold written test followed by interview, the procedure of which will be intimated later on.
7. The prescribed essential qualifications are the minimum and mere possession of the same does not entitle a candidate to be called for interview. In the event of number of applications being large, the Institute will resort to short listing criteria to restrict the number of candidates to be called for interview to a reasonable limit by written test and/or any other criteria.
8. Only Indian Nationals are eligible to apply

9. All short-listed candidates will be intimated the date of written test and interview at their respective email IDs. The list will also be available in the website of the Institute. No individual letter to the candidates will be sent.
10. Before applying, the applicants should ensure that they possess at least the essential qualifications laid down for the post and other conditions stipulated in the advertisement. If a candidate is found not eligible, his candidature will be cancelled at any stage of the recruitment. It may be noted that even if a candidate qualifies in the test/interview and subsequently it is found that he/she does not fulfill the eligibility criteria, his/her candidature will be cancelled.

12. Candidates working in Government/Semi Government/ PSU/Autonomous Bodies etc. Shall also produce No Objection Certificate at the time of interview, if called for.
